### Objectives

This award recognizes rigorously conducted and societally beneficial research contributing knowledge with the potential to make the world a better place. Responsible research gives rise to both credible and useful knowledge. Credibility refers to the reliability, validity, and trustworthiness of findings, in either inductive or deductive work, using qualitative data, quantitative data, or both. Usefulness refers to the potential of the knowledge to inform policy and influence practice. We call for nominations of published work that exemplifies these [principles of responsible research](#).

### Submission Criteria

We invite nominations or self-nominations of **empirical** research articles or research books, written in the English language and published within the last four years (2019-2022) that meet the following criteria:

- Research that exemplifies the [Seven Principles of Responsible Research](#).
- Research situated at any level of analysis (individual, team, organization, society), investigating any kind of organization (business, non-profit, governmental), and focusing on any region of the world. Qualitative and/or quantitative reviews of accumulated robust evidence of problems or solutions are also suitable.
- Research published in a refereed journal (or accepted) or in a book published by a university or academic press such as Harvard, Stanford, Oxford, Cambridge, Sage, Wiley, Routledge, etc.

### Submission Procedures

- Submit your nomination(s) to [https://www.rrbm.network/rrma23\\_nomination/](https://www.rrbm.network/rrma23_nomination/) by January 31, 2023.
  - Upload a PDF copy of the article or book, a pre-print, or finalized manuscript for in-press articles or books.
  - Upload in PDF a nomination letter in no more than one single-spaced page that describes:
    - Why this work (research article or book) deserves to be considered for the Award.
    - Any available evidence demonstrating i) how this work has made a positive impact on practice, and ii) how this work has been disseminated to stakeholders beyond the academic community.
  - Nominations will be evaluated by (1) Fellows of AOM, and (2) a panel of practicing executives.
  - Winners of the award will be informed on or before June 15, 2023.
